
4th largest area of transnational crime (after drugs, counterfeit and human trafficking)



Global freshwater use over the long-run




Global freshwater withdrawals for agriculture, industry and domestic uses since 1900, measured in cubic metres (m³) per year.



India: Crimes under the Air and Water Prevention and Pollution Control act

2019 - 160 cases

2020 - 589 cases

286% growth

Interpol Operation 30 Days at Sea (2021) – 1600 marine pollution offences detected in 1 month

from expected annual property damage due to flooding



Challenges

Some of the challenges in addressing water related crime

- No single definition
- Very varied national legislation
- Lack of statistics and water offences being recorded under other offence categories
- Reluctance to prosecute and lack of knowledge and culture of enforcement
- Addressing most offences under administrative law
- Lack of monitoring and enforcement capacity
- De-prioritization due to collectivity and anonymity of victims
- Difficulties in establishing causation links
- Complex "significance" tests
- Insufficiently deterring penalties
